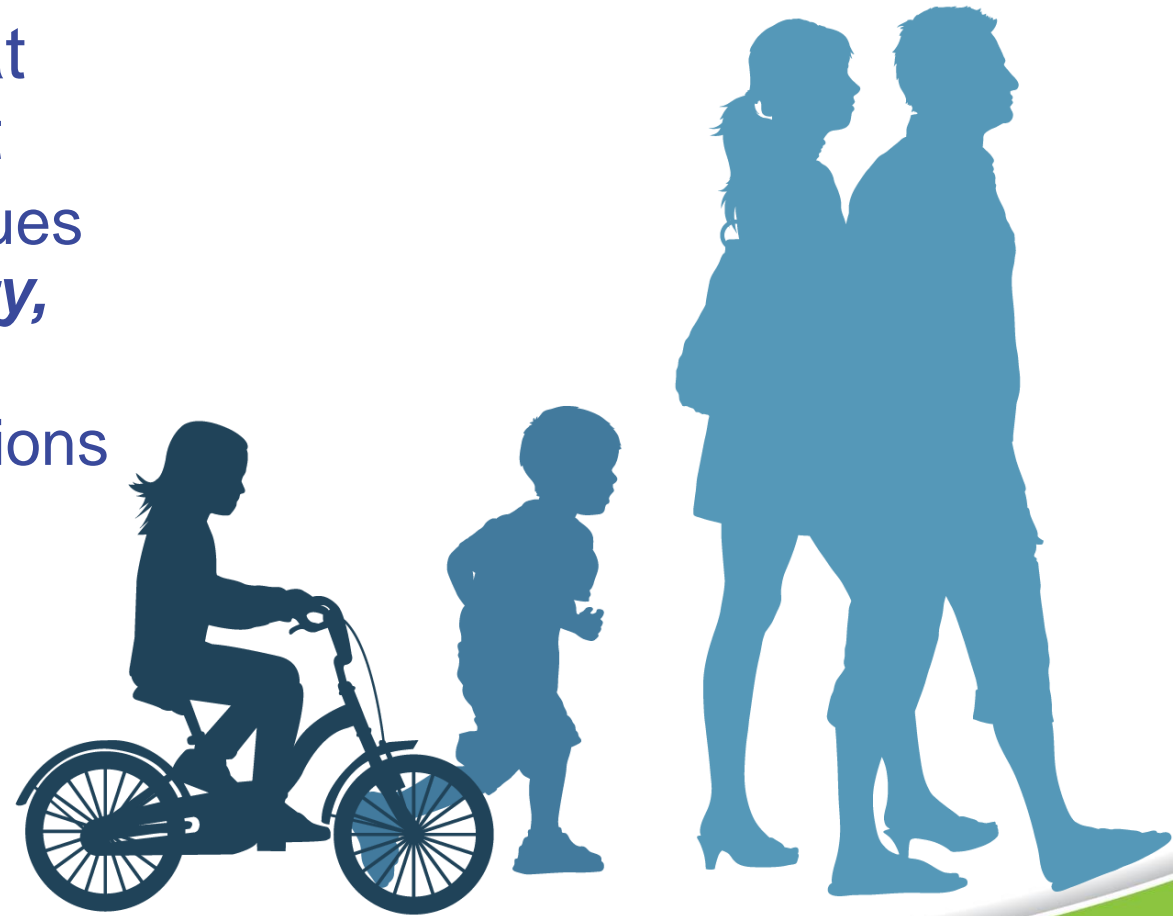

 - Identify potential alternatives or solutions such as ***engineering treatments, policy changes, or education and enforcement measures***

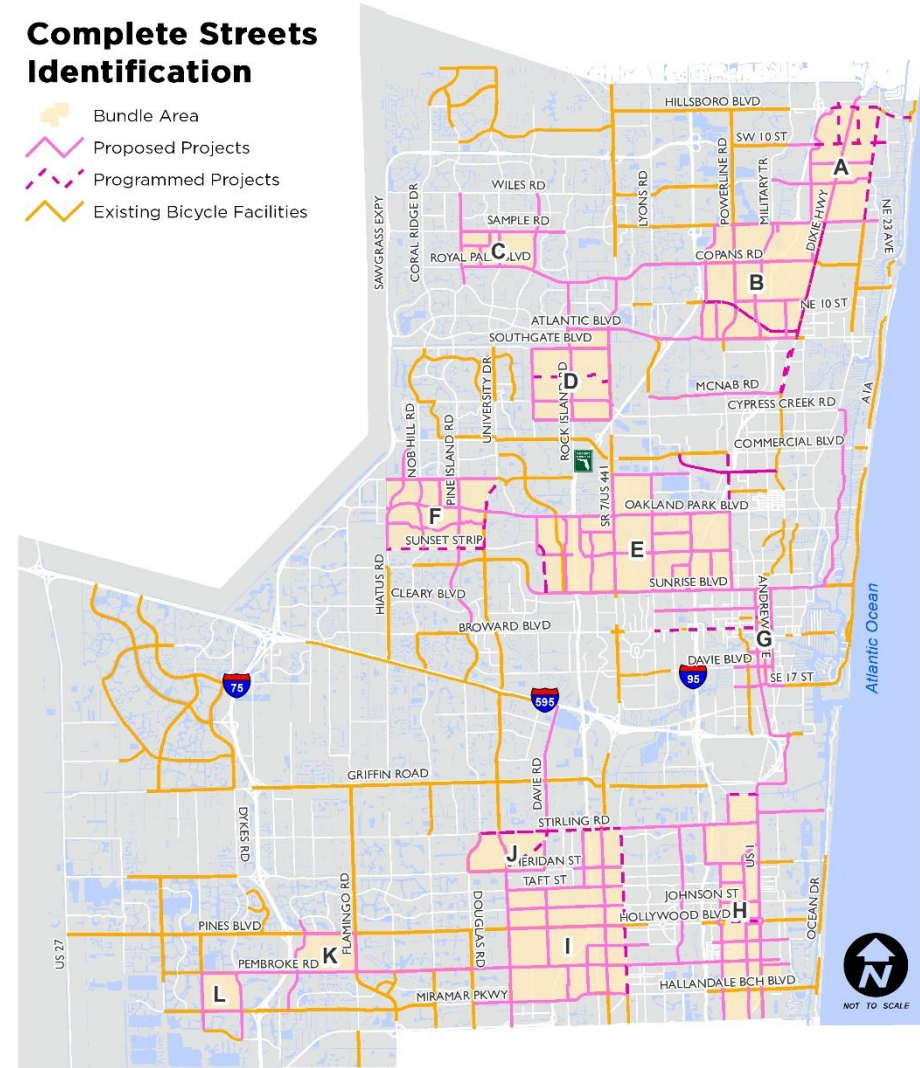


Complete Streets Master Plan

- Intended to guide **future investment** in Complete Streets improvements by developing a *prioritized list of projects* based on technical, data-driven analysis, including access to transit
- Help inform the **scoping** of key projects that will be incorporated into the Work Program

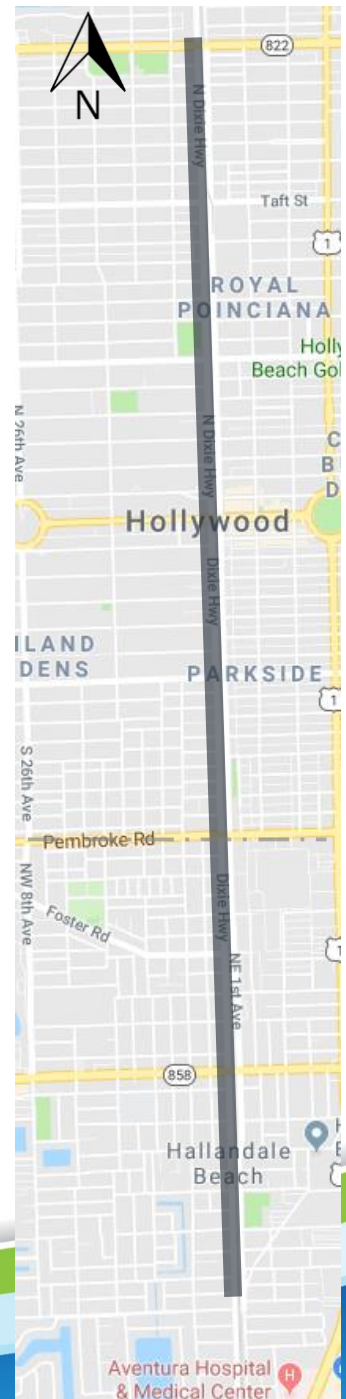
Complete Streets Identification

Dixie Highway/N/S 21st Avenue/NE/SE 1st Avenue from County Line Road to Sheridan Street

- Green color bicycle lanes, continuous pedestrian zone (sidewalk gaps), and furnishing zone.
 - Length: ~5.2 miles
 - One-way pair
 - Dixie Highway (SB)
 - 2017 AADT: 6,400-11,000
 - 35-40 miles per hour
 - 3-4 Lane Roadway
 - N/S 21st Avenue/NE/SE 1st Avenue (NB)
 - 2017 AADT: 3,500-13,000
 - 35 miles per hour
 - 2-3 Lane Roadway

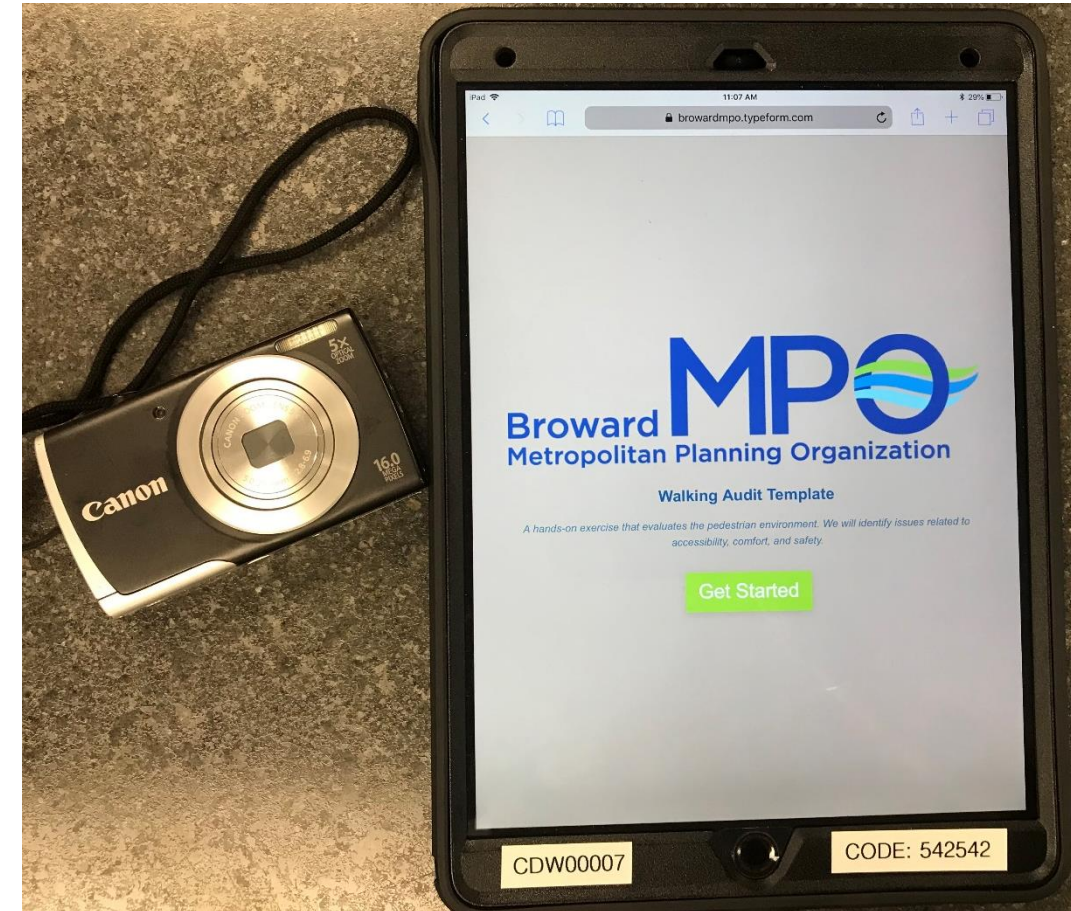

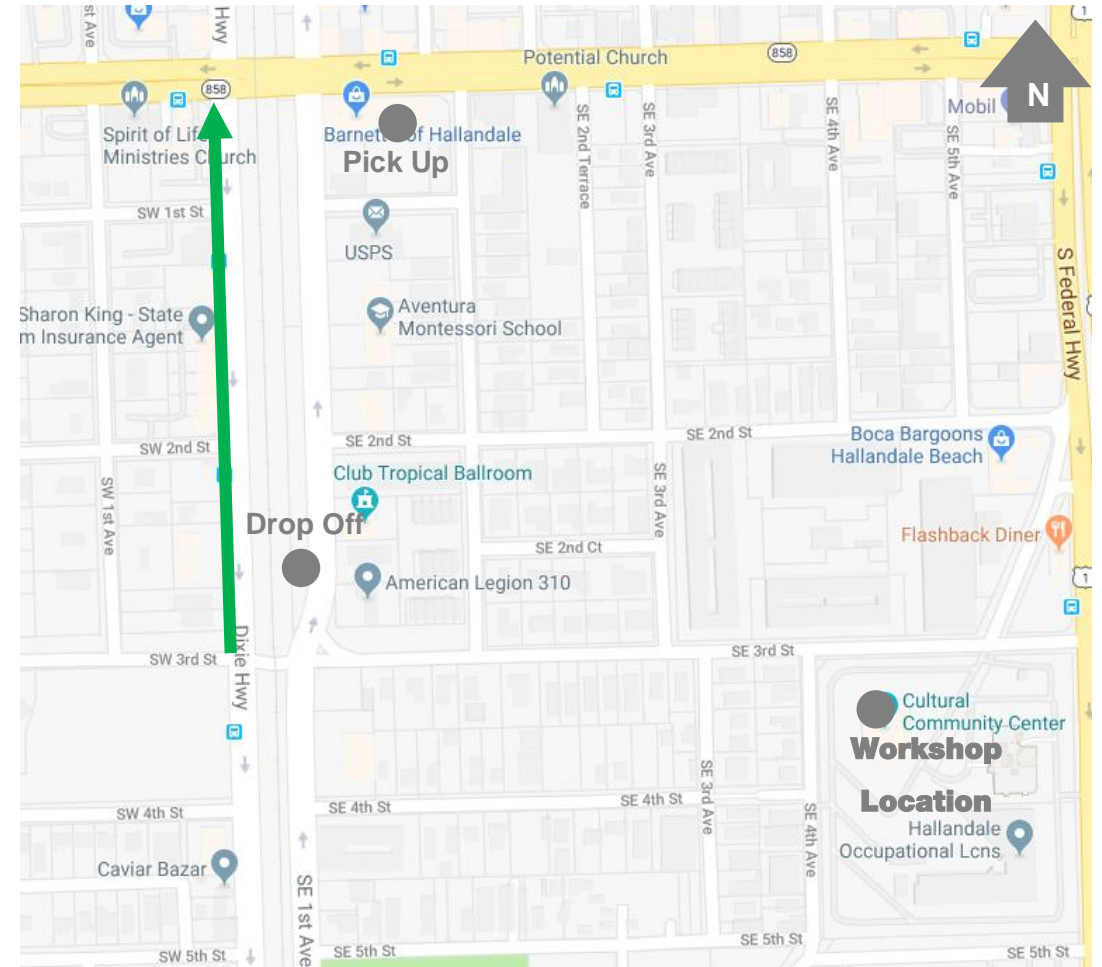
Walking Audit

- Participants are encouraged to take notes and photos



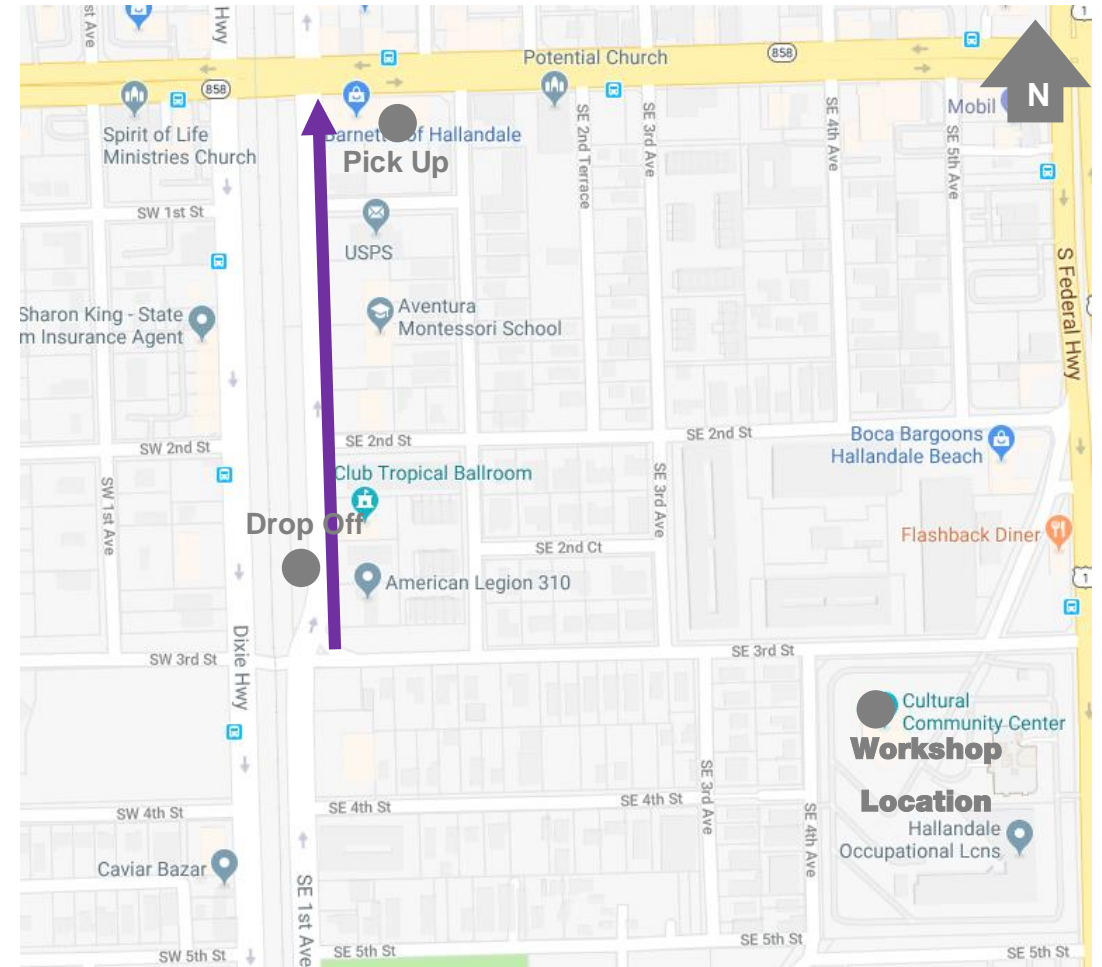
Walking Audit

Route 1



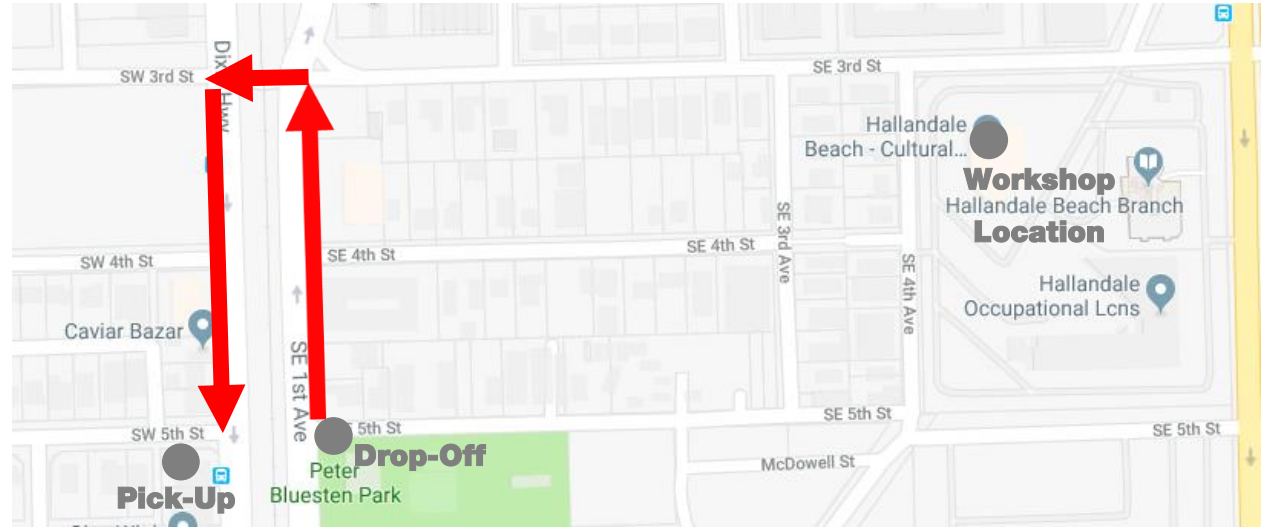
