Bus Industries (NABI), these 40-foot long buses will introduce an array of modern features, including an updated fare box, vinyl flooring, a new surveillance system, and "Stop Request Signs" that show date, time and stop requests for the hearing and visually impaired. The bus engines will operate on electrical power, helping to improve fuel efficiency, eliminate exhaust fumes, reduce noise, and allow for smoother operation.

The festival featured a spectacular array of entertainment, great food and heritage; promoting awareness of the communities Coral Springs represents.



and services from place to place, the Broward MPO continues to encourage the community at large to consider alternatives that reduce single occupancy vehicular travel. The Broward MPO encourages the community to utilize appropriate transportation systems while considering important components, such as air quality, eco-friendly modes of transportation, ridesharing, and alternative fuels, just to name a few.

The Broward MPO continues to play a critical role in shaping the transportation issues in our local communities. Some of the highlights of these efforts are featured in this issue, with recent participation in events such as "Dump the Pump Day" and "Clean Air Month." Each example herein gives ways the Broward MPO has helped contribute to South Florida's step towards a "greener" environment, not just in our county, but regionally and statewide.

Organizations and community members across the region are doing their part to conserve the planet by reducing pollution. One example, ridership on Tri-Rail has increased by 20.8 percent in just the first half of 2008. In addition, more and more members of the community are opting to carpool.

In another example, organizations, such as the Florida Department of Transportation (FDOT), are offering their employees flexible work schedules as a cost savings measure. Effective September 29th, the City of Margate will convert to a four-day, 10-hour work schedule, estimating a savings of 20 percent in operating costs associated with lights, air conditioning and fuel.

Taking public transportation is one thing that millions of people do, and can do on a regular basis to help improve the environment. Although Clean Air Month is only celebrated once a year, South Florida's communities continue to focus on how we can individually and collectively make a difference.

2008 METROPOLITAN PLANNING ORGANIZATIONS' (MPO) CITIZENS' ADVISORY COMMITTEE (CAC) **REGIONAL MEETING**

Each year, the Broward, Palm Beach and Miami-Dade MPOs come together so members of each advisory board have the opportunity to meet and review current and future transportation projects that have regional impact.

The 2008 Regional CAC Meeting took place on Wednesday, June 11, 2008 at the South Florida Regional Transportation Authority's (SFRTA) Administrative Offices in Pompano Beach. The meeting's board of panelists included representatives from all three organizations in the tri-county area, including Broward's Community Involvement Roundtable (CIR), Miami-Dade's Citizens Transportation Advisory Committee (CTAC), and Palm Beach's CAC.

Judy Daversa, of the Palm Beach CAC chaired the meeting. Also present on the board of panelists, John Rude, Chair for Broward MPO's CIR. The audience included approximately 20 members of the public, as well as constituents from various transportation agencies.

The meeting kicked off with an opening statement from Joe Giuletti, Executive Director of the SFRTA.

Committee members and the audience were then given the opportunity to make comments and ask questions on projects, plans, and other issues affecting their communities. Major topics on the agenda included:

The 2035 LRTP is scheduled to be adopted in December 2009. The plan update includes an intensive public involvement program to ensure new projects in the plan are consistent with community values.

The public involvement program includes 20 public meetings and workshops conducted throughout Broward County. Five workshops were conducted the last two weeks of July 2008, five public meetings will be conducted in the fall of 2008, an additional five workshops and five public meetings will be conducted near spring 2009 prior to LRTP adoption.

Broward Beautiful Breaks Ground on Third Greening Gateways Project

State and Broward County officials, along with representatives from the City of Oakland Park, the City of Wilton Manors and partners, such as the Tree Preservation Trust Fund, came together on May 22, 2008 to break ground and celebrate the third Greening Gateways landscape project.

Greening Gateways is an initiative of Broward County's Broward Beautiful to bring partners together to make enhancements to the Interstate Gateways of Broward County. This ceremony marks the culmination of nearly three years of planning to enhance the beauty and improve the environment at the I-95/Oakland Park Boulevard Interchange.

With the total estimated project cost at \$1,125,000 for landscape improvements, each of Broward Beautiful's partners for this project came together to successfully raise funds through several county, state and federal grant programs. Broward MPO participated by contributing \$500,000 through the Transportation Enhancement Grant program.

The project is scheduled to add more than 22,000 trees and plants to enhance one of Broward's busiest interchanges.
