

CYPRESS CREEK MOBILITY HUB MASTER PLAN

The Cypress Creek Mobility Hub, located off of I-95 and Cypress Creek Road in Fort Lauderdale, is the second largest employment center in Broward County. Home to a growing business community, the Hub also includes a variety of transportation options, including the Cypress Creek Tri-Rail Station, Tri-Rail Shuttles, three Broward County Transit (BCT) routes, and an I-95 interchange. Due to the high travel volume and various transportation modes, the Broward MPO and the South Florida Regional Transportation Authority (SFRTA) identified the need for the development of the Cypress Creek Mobility Hub Master Plan. Study partners include the Florida Department of Transportation (FDOT), Broward County, the City of Fort Lauderdale, the City of Oakland Park, and Envision Uptown, the business organization for the Cypress Creek/

Uptown area. The goal of the Mobility Hub Master Plan is to examine efficient transportation connections that will spur continued growth and development, enhance walkability, and promote the use of multiple modes of transportation within the Cypress Creek Mobility Hub area.

The Master Plan Study examines existing conditions of the Mobility Hub, and identifies potential strategies for improving transit connections, along with encouraging economic development and promoting a safe environment for pedestrian and bicycle activity. The Master Plan will go before the Broward MPO Board for adoption in early 2016, with funding for the implementation of recommendations in 2017.

MESSAGE FROM THE CHAIR

In an effort to add more voices to the transportation decision-making process, the Broward MPO Board has decided to expand the MPO voting membership from 19 to 25. The current structure of the Board consists of 19 voting members and 18 alternate members representing the 31 municipalities in Broward County, the Broward County Commission, the South Florida Regional Transportation Authority (SFRTA), and the Broward County School Board. While each alternate member does participate in the lively discussion and debate, not everyone can actually vote on the issues that come before the Board. Alternate member are allowed, in order of population, to vote only when regular voting members are absent.

With this change, the cities of Coconut Creek, Hallandale Beach, Margate, North Lauderdale and Oakland Park will now have a more direct influence on the direction of the Board, and the Broward County Commission will gain an additional representative. We believe that by expanding the MPO voting membership, we are promoting the ability for all municipalities (large and small) to be heard, and ensuring that transportation projects are distributed equitably throughout our region. When all of our communities participate in the transportation planning process, we can better serve the residents and businesses who depend on our roads, trains, buses, and skies to get around.

On January 29, 2016, the Broward MPO's third annual Safe Streets Summit will take place at the DoubleTree Hotel in Deerfield Beach from 8:00 am to 5:30 pm. Additional highlights of the 2016 Summit include speakers Barbara McCann, Director of the U.S.

Department of Transportation's Office of Safety, Energy and Environment, and Charles Marohn, President and Founder of Strong Towns. The event will also feature a free trolley ride to Deerfield Beach's pedestrian-friendly oceanfront immediately following the day's events.




Construction Career Days

On October 20th and 21st, the Broward MPO attended the annual South Florida Construction Career Days, held at the Bergeron Rodeo Grounds in Davie. MPO staff participated in this year's event by teaching local students about Complete Streets using StreetMix software, which allows users to design the kind of street where they would like to live. Students added elements to the streets such as transit shelters, bike lanes, and landscaping to make their streets more appealing.

Since 1999, Construction Career Days has been an important outreach program to encourage high school students to pursue careers in the transportation and construction industries. With the influx of new Florida residents and the booming tourism industry, the demand for qualified and skilled construction workers continues to increase.
