TRAC AND RIDES: MENTORING THE NEXT GENERATION

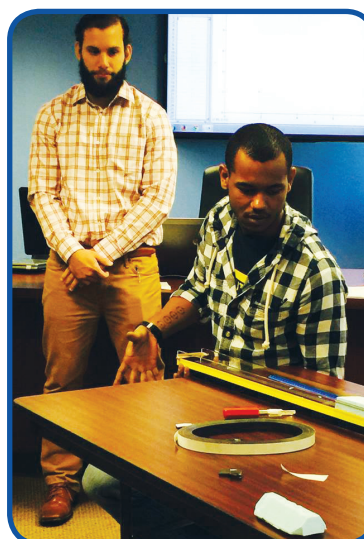
On February 10th and 11, 2015, the Broward MPO, in coordination with the **Federal Highway Administration (FHWA)**, held **Transportation and Civil Engineering (TRAC)** training sessions for Broward's Middle and High School teachers. In an effort to bring awareness to and raise interest in engineering professions, TRAC is designed to provide educators with hands-on, training experience in the fields of science, technology, engineering and math, also known as STEM. The TRAC initiative, and its elementary school counterpart, **Roadways Into Developing Elementary Students (RIDES)**, developed at the nationwide level by the **American Association of State Highway Transportation Officials (AASHTO)**, is offered to all states, by way of their respective Departments of Transportation.

Teachers actively participated in hands-on lab work and activities including bridge building, magnetism, traffic technology, and highway safety. As reflected in the 2015 Broward MPO Strategic Plan, educational outreach and involvement with regard to STEM-oriented curriculum are essential for the continuation of the transportation and engineering industries. Working in close concert with Broward County Superintendent of Schools, Robert W. Runcie, and Broward County's Math, Science, and Gifted Department, the Broward MPO aims to provide the County's educators with the necessary tools to encourage their students' interests in the fields of math and science. As the current leaders in transportation begin to reach the age of retirement, colloquially referred to as the "Silver Tsunami," many DOTs across the nation are concerned about the state of the industry; therefore, it is especially important to encourage young peoples' participation. It is through programs such as TRAC and working relationships between school boards and public agencies, that students of all ages are introduced to the exciting worlds of transportation and civil engineering. This continuing partnership is a high priority for the Broward MPO, not only for 2015, but also for the years beyond!

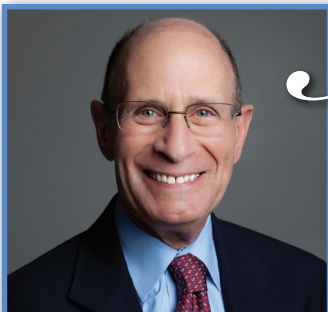

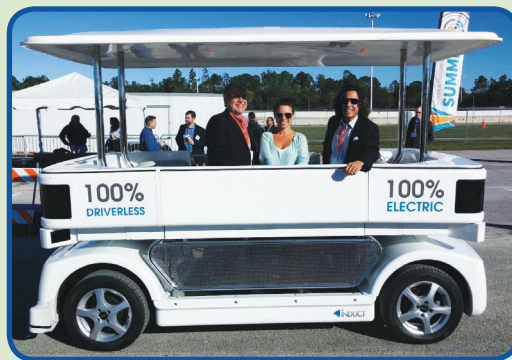
2nd Annual Automated Vehicles Summit

On December 15th and 16th, 2014, the Florida Department of Transportation hosted the 2nd Annual Automated Vehicles Summit at Walt Disney World Resort in Orlando, Florida. Attended by many transportation professionals, as well as Broward MPO's own Greg Stuart, and Board Member Javier Garcia. The two-day Summit began with

meetings and presentations about the state of the transportation industry, as well as specific information about FDOT's efforts to increase State highway safety. Day Two included live demonstrations of automated vehicles on the Walt Disney World Speedway. In addition to the Summit, the Broward MPO Board and the Local Coordinating Board were further educated, on two separate occasions, by presentations by FDOT Assistant Secretary, Richard Biter.



Americans with Disabilities Act Celebrates 25 Years

The Broward MPO, along with Kimley-Horn and Accessology, hosted a public roundtable

discussion regarding the necessity for local municipalities to ensure the existence of an Americans with Disabilities Act (ADA) Transition Plan on February 19th. This 3-hour discussion provided attendees with pertinent information regarding the specific Transition Plan Requirements, highlighting the fact that the Department of Justice is strictly enforcing compliance, especially Title II entities in 2015—the ADA's 25th Anniversary. With over 70 registrants, the roundtable was a lively, informative event, bringing the necessary awareness to ensure that Broward continues to be a safe and accessible area for all.
