Existing Conditions




- 85% of all fatal and serious injury crashes occur on 8.5% of streets.
- Roadway Fatalities (2016-2022) = 1,126
- Average Annual Fatality Rate per 100,000 population (2016-2022) = 11.7
- 64 Rail Incidents since 2018



What is SS4A?



Safe Streets and Roads for All (SS4A)

- Discretionary competitive grant program established by the Bipartisan Infrastructure Law (BIL)
- \$5 billion in appropriated funds over 5 years (2022-2026)
- Dedicated funding for safety projects to prevent fatalities and severe injuries on roadways
- Grant Types
 - Action Plan
 - Supplemental Action Plan
 - Implementation Grant
- 20% Non-Federal Match is required

What is SS4A?

Why did MPO apply for an Action Plan?

- Broward does not have comprehensive safety plan that meets requirements for Implementation Grant
- Broward MPO has proven to effectively and efficiently administer competitive federal grants
- Broward MPO applied as lead with Broward County to maximize award of \$5 million
- Comprehensive Safety plan will be able to integrate various safety needs county wide
- Action Plan will allow Broward MPO, Broward County and municipalities to apply for federal implementation grants

SS4A Grant Priorities

- Demonstrate engagement with a variety of public and private stakeholders
- Promote safety
- Seek to adopt innovative technologies and strategies
- Employ low-cost, high-impact strategies that can improve safety over a wider geographic area

- Ensure equitable investment in the safety needs of underserved communities, which includes both underserved urban and rural communities
- Incorporate evidence-based projects and strategies
- Align with the Department's mission and with priorities such as equity, climate and sustainability, quality job creation, and economic strength and global competitiveness.

General Scope Outcomes

The ACTION PLAN is a joint commitment between the Broward MPO and Broward County as PARTNERS to:

- 1. Create an **ACTION PLAN with defined goals** to improve safety for all roadway users, including vulnerable users (pedestrians, bicyclists, public transportation users, micromobility and other non-motor vehicle users).
- 2. Identify projects and prepare them for funding and implementation.
- Identify policies and programs to increase safety for roadway users and prevent roadway deaths and serious injuries.



Broward Region SS4A Narrative

Introduction

Broward County, Florida, is part of the **14th most dangerous region in the country** as identified in the 2022 Dangerous By Design report. Though local governments have adopted Vision Zero safety performance measures, meaningful change is not occurring fast enough. Broward Metropolitan Planning Organization (BMPO), lead applicant, with Broward County government, joint applicant, are requesting a **\$5 million Safe Streets** and Roads for All (SS4A) grant award to develop a Comprehensive Safety Action Plan (AP). The County will provide a **\$1.25 million local match**.

Broward Region SS4A Narrative

Action Plan

An inclusive analysis of facilities, crash data, policies, and equity will be conducted. This process will provide **low cost**, **high impact approaches** such as region-wide safe speeds strategies, Complete Streets and Vision Zero policies, and deployment strategies for innovative technologies. **Infrastructure improvements** such as separated facilities, low-stress multimodal safety projects, school zone and intersection safety improvements will be identified. The principles of the **Safe Systems Approach and various published design guidance** (ex. NACTO) will inform recommendations. **Innovative technology** (ex. near-miss identification, AI traffic signal and detection, Smart City) strategies and projects will be reflected in the AP. **Projects will be identified and prioritized as short and long-term projects**.

Broward Region SS4A Narrative

Public Outreach

BMPO will utilize its **successful data-driven**, **equity-based public outreach** strategies to involve all communities. **High-tech strategies** will employ social media and on-line surveys, while **high-touch strategies** will focus on leveraging existing relationships with partners who have well-established programs in traditionally underrepresented communities. A diverse **oversight board** will be established to guide the development of an equitable and well-informed AP. It will include representatives from the health industry, law enforcement, private sector, elected officials, and community champions.

Safety will be evaluated from a **holistic perspective** throughout the County. The SS4A grant will provide the opportunity to reduce **severe in juries and traffic fatalities to zero**.

Project Description

From the Memorandum of Understanding

BMPO will lead the process to procure services of a consultant team (Consultant) to develop an Action Plan that:

- a. Provides **safety recommendations** (policies, countermeasures, and project recommendations) **through a variety of safety lenses** identified by the Partners. The Action Plan will provide recommendations that will address identified safety needs in Broward County: Complete Streets, Vision Zero, safe speeds, technology, mid-block crossings, lighting, speeding in neighborhoods, high-risk network, railroad safety, school zone, and Quick Build projects.
 - The Action Plan will **incorporate Broward County studies** that may include but are not limited to the Broward County Low Stress Multimodal Mobility Transportation System Master Plan, Near-Miss Traffic Incident Identification System at Signalized Intersections for Proactive Roadway Safety Analytics and Mobility Enhancement, and Countywide Intersections Study.

- Meaningful public involvement with an emphasis on underserved communities
