3	275	SFRTA	LCD Visual Monitors at Tri-Rail Stations	Install two LCD Visual Monitors on the platforms at each of the seven Tri-Rail stations in Broward County to display real-time trip information.	\$ 788,810.35
4	270	Oakland Park	NE 15th Ave and Side Street Improvements	Construct sidewalks along NE 15th Ave as well as the cross streets from NE 32nd St to NE 37 St extending from NE 13th Ave to NE 16th Ave.	\$ 1,157,785.94

7	255	Plantation	Citywide Sidewalk Improvements	Construct new sidewalks on Cypress Road and Central Park Drive and widen the existing sidewalk on Plantation Road.	\$ 987,479.32
8	250	Deerfield Beach	NE 3rd Avenue Complete Streets Project	Convert a four-lane roadway to three-lanes, buffered bicycle lanes, replace a four-way stop with a roundabout, mid block crosswalk with HAWK pedestrian signal.	\$ 2,872,941.97
9	245	Hallandale Beach	Atlantic Shores Blvd Complete Streets	Project includes widened sidewalks, raised pedestrian crossings, roundabout, addition of and improved on-street parking, and pedestrian lighting.	\$ 9,672,355.23
10	200	Sunrise	Dedicated Bicycle Lanes and Traffic Circle	Provide dedicated bicycle lanes on NW 94th Ave, NW 42nd St and NW 50th St. Install a roundabout at NW 94th Ave and NW 42nd St.	\$ 2,397,096.21
11	190	Coral Springs	NW 40th St Pedestrian Improvements	Replace asphalt sidewalks with a wider concrete multi-use path, expand existing multi-use path and replace with concrete, install roundabouts, and new curb and gutter.	\$ 2,612,682.13

13	160	Weston	Bonaventure Area Bicycle Facilities	Addition of bicycle facilities on Blatt Blvd, Racquet Club Rd, Lakeview Dr, E. Mall Rd, and W. Mall Rd. At segments where existing conditions don't allow 5' bicycle lanes, sharrows are proposed.	\$ 899,334.13
14	255	Fort Lauderdale	NE 26th Street Mobility Project	Project will construct sidewalks, bike lanes, raised intersections, tighten turning radii and add a roundabout.	\$ 1,919,881.54
15	250	Plantation	Traffic Calming Project	Install speed tables, traffic circles, and center medians on Cypress Rd and NW 11th Place.	\$ 809,004.32
16	245	Hollywood	Citywide Traffic Calming Project	Install traffic calming measures such as speed tables and roundabouts on nine streets located throughout the City.	\$ 3,521,447.04
